Any credit card or debit card transactions are enforceable under § 32.31 prosecution as a state jail felony.
4. Possession--I understand possession is subject to the full payment of the purchase price. The removal of any horse(s) without providing such is a felony theft under TX Penal Code § 31.03(e)(4)-(5) and shall be prosecuted to the full extent of the law. In such event, I agree to pay any and all additional fees incurred by the Blue Valentine Driftwood Connection in the collection of damages, associated fees, including but not limited to, the repossession of said horse(s).
